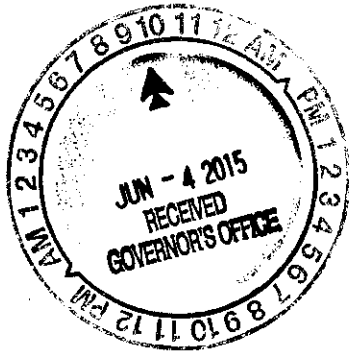

2 ENROLLED, An Act,

3 Relating to garnishment; to add a new Section
4 30-3-69.1 to Article 3, Chapter 3, Title 30, Code of Alabama
5 1975, to provide that an employer who pays an employee in a
6 manner that protects the wages of the employee from
7 garnishment or withholding laws to be personally liable for
8 the child support that could have been garnished or withheld.

9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

10 Section 1. Section 30-3-69.1 is added to Article 3,
11 Chapter 3, Title 30 of the Code of Alabama 1975, to read as
12 follows:

13 §30-3-69.1.

14 An employer who pays his or her employee in a manner
15 intending to protect the wages of the employee from being
16 garnished or withheld for the purpose of or the collection of
17 child support payments owed by the employee shall be
18 personally liable for the amount of child support owed as if
19 the child support had been withheld under Chapter 3 of this
20 title or to the same degree as an employer who willfully fails
21 or refuses to withhold or pay the amounts required under
22 Section 30-3-69.

23 Proof of the employer's intent to protect the wages
24 of the employee in a manner violating this section must be
25 established by clear and convincing evidence.

1 Section 2. This act shall become effective on the
2 first day of the third month following its passage and
3 approval by the Governor, or its otherwise becoming law.
